\*Dollar General – things are moving forward projected start date in the spring, subject to change

\*Tanya will be sending out the tree and parade letters in the next few weeks. The Tree lighting will be held Nov 26<sup>th</sup> and the Parade will be December 9<sup>th</sup>.
